

Jan Kelly Presentation: Train Accidents, Intersection Blockage and Air Pollution coming from a rail yard in Vancouver. All this is happening near Clark County!

To bring some perspective to the discussion: If the mines in Chelatchie Prairie start up and the rock begins to move on the Chelatchie Prairie RR (Class 3 RR) any and all of the examples could happen to our neighborhoods and beyond.

Remember this: When there is a train accident, or derailment of rail cars occurs, or pollution spews into the air from the diesel engines needing repairs it makes no difference what the grade of train line is. The impact will be the same, and it will be the community that will suffer.

We need to let those in the county know what our opinions, concerns, and expectations are regarding the train operations, the RR Overlay, and the rezoning of AG and residential land to heavy industrial next to residential developments and our schools.

We have the power of the ballot box. This is a short election cycle. Primary in August, general election in November. Get informed of the issues and candidates.

Will you join our efforts to stop this activity before an accident happens, property is destroyed, or an innocent death occurs due to an intersection being blocked by the rail cars?
